Cyflawni Mwy Gyda'n Gilydd tuag at Dde Cymru Mwy Diogel

De Cymru yw un o'r ardaloedd mwyaf diogel i fyw a gweithio ynddi yn y DU ond mae'r pwysau dwys ar blismona a gwasanaethau eraill yn golygu bod angen ystyried yn ofalus iawn pa lefel o dreth gyngor sydd ei hangen er mwyn cynorthwyo ein cymunedau a mynd i'r afael â bygythiadau trosedd sy'n dod i'r amlwg.

Mae Cynllun yr Heddlu a Throseddu 2023-27 y Comisiynydd yn ymwneud â diogelu ein pobl, yn enwedig pobl agored i niwed, a gweithio hyd yn oed yn agosach gyda chymunedau lleol. Cafodd y cynllun ei lunio mewn cydwethriad agos â'r Prif Gwnstabl ac mae'n nodi ein gweledigaeth ar gyfer plismona yn Ne Cymru. Mae'n parhau i roi pwyslais clir ar ymyrryd yn gynnar a chymryd camau prylion a chadarnhaol. Mae'r Cynllun yn nodi sut y byddwn yn delio â throsedd a niwed, fel trais yn erbyn menywod, cam-drin domestig a thrais rhywiol, troseddau wedi'u galluogi gan y rhyngrywd, camfanteisio'n rhywiol ar blant a chamfanteisio ar y rheini sydd fwyaf agored i niwed.

Rydym yn croesawu ymrwymiad cenedlaethol y Llywodraeth i recrifiwto Swyddogion yr Heddlu newydd, ond bydd yn golygu y bydd cyfran uchel o'r gweithlu bellach yn newydd i'r gwasanaeth, a ni wna unrhyw beth i wneud iawn am y traean a mwy a gollwyd o Grant yr Heddlu o'r Swyddfa Gartref ers 2012.

Heblaw am y cyllid ar gyfer swyddogion newydd, roedd Grant yr Heddlu ar gyfer 2024/25 yn setliad arian gwastad arall, heb roi fawr ddim ystyriaeth i chwyddiant na chostau eraill. Mae bwllch cyllido o £16.6 miliwn yng nghyllideb Heddlu De Cymru ar ôl cael £9 miliwn o gynllion eisoes wedi'u rhoi yn y gyllideb. Roeddym yn arfer cael £3 miliwn y flwyddyn fel grant tuag at brosiectau cyfalaf, ond mae hynny wedi dirwyn i ben, a rhaid cyllido'r holl wariant cyfalaf gan ddefnyddio cyllid refeniu mewnol yn gyfan gwbl. Rydym hefyd dan anfantais o beidio â chael £1 miliwn yn flynyddol ar gyfer costau hyfforddiant, o'i gymharu â Heddluoedd yn Lloegr.

Mae'n rhaid i'r praecept gwmpasu'r bylchau hyn, ar ben y £72 miliwn o arbedion cyfunol (toriadau) y llwyddwyd i'w cyflawni ers 2010. Y canlyniad, o ystyried yr holl heriau hyn, yw cynnydd ym Mhraecept yr Heddlu o £28.20 y flwyddyn (£2.35 y mis) ar gyfer eiddo Band D (mae ein praecept bellach wedi cyrraedd y cyfartaledd yng Nghymru bellach), ond bydd y rhan fwyaf o bobl yn talu llawer llai na hyn. Mae Comisiynydd yr Heddlu a Throseddu De Cymru wedi pennu'r dreth gyngor ar £352.67 ar gyfer eiddo Band D, gan gyfrannu £180.3 miliwn at y gyllideb o £387m ar gyfer gwasanaeth heddlu 24 awr, saith diwrnod yr wythnos.

Er gwaethaf yr heriau ariannol, rydym wedi gwella perfformiad yn gyson ac wedi lleihau agweddau ar droseddu a niwed, gan ddarparu bron £1biliwn o fudd cymdeithasol ac economaidd i bobl De Cymru dros y degawd diwethaf. Mae ein perfformiad wedi cael ei gydnabod gan Arolygiaeth Cwnstabliaeth Ei Fawrhydi hefyd:

"De Cymru sydd fwyaf gweledol o blith y 43 o gwnstablaethau ac mae yn y safle cyntaf o ran cyflawni'r canlyniadau cadarnhaol gorau yn y wlad ar gyfer trais gydag anaf ac ar weithredu yn erbyn troseddau rhywiol."

Achieving More Together Towards a Safer South Wales

South Wales is one of the safest areas to live and work in the UK but the intense pressure on policing and other services makes it necessary to give very careful consideration to the level of council tax needed to support our communities and address emerging crime threats.

The Commissioner's Police and Crime Plan 2023-27 is about protecting our people, particularly the vulnerable, and working ever more closely with local communities. The plan was produced in close co-operation with the Chief Constable and sets out our vision for policing in South Wales. It continues to provide a clear emphasis on prevention, early intervention and prompt, positive action. The Plan sets out how we will deal with crime and harm including violence against women, domestic violence and abuse and sexual violence, internet enabled crime, child sexual exploitation and the exploitation of those who are most vulnerable.

The new Police Officers provided through the Government's national commitment are welcomed but it means that a high proportion of the workforce are new in service, and it does nothing to address the loss of over a third of the Police Grant from the Home Office since 2012.

Apart from funds for the new officers, the Police Grant for 2024/25 was another flat cash settlement with minimum allowance for inflation or other cost pressures. There is a funding gap of £16.6m in South Wales Police's budget after £9m of savings already built into the budget. We used to receive £3m a year as a grant towards capital projects but that has ended, and all capital expenditure has to be financed entirely by our own revenue funds. We are also disadvantaged to the tune of £1m annually with respect to training costs, compared to Forces in England.

The precept has to cover these gaps, on top of the £72m recurring savings (cuts) we have delivered since 2010. Given all these challenges the result is an increase in the Police Precept of £28.20 a year (£2.35 a month) for band D properties (our precept is now at the Welsh average), while most people will pay much less than this. The Police and Crime Commissioner for South Wales has set the council tax at £352.67 for a Band D property, contributing £180.3m towards the £387m budget for a 24-hour, seven-days-a-week police service.

Despite the financial challenges, we have consistently improved performance and reduced aspects of crime and harm, delivering almost £1billion of social and economic benefit to the people of South Wales over the past decade. Performance has also been recognised by HM Inspectorate of Constabulary:

"South Wales has the best visibility across 43 constabularies, whilst it is ranked 1st in the country for positive outcome rates for violence with injury and 1st for taking action on sexual offences".
