- 1. THIS NOTICE** is issued by the Council, in exercise of the power conferred by Section 173ZA of the above Act. The Council consider that there has been a breach of planning control on the land described in paragraph 2 below.

The Council consider it expedient to issue this notice, as having regard to the provisions of the Local Development Plan and to other material considerations, there is a reasonable prospect that, if an application for planning permission in respect of the development stated in paragraph 3 below were made, planning permission would be granted subject to condition.

Important additional information is given in the Annex to this notice.

- 2. THE LAND TO WHICH THIS NOTICE RELATES**

Land at Spring Mills, Berthlwydd, Penclawdd Road Gowerton Swansea SA4 3RB in the City and County of Swansea ("the Land"), shown edged red on the plan appended hereto ("the Plan").

- 3. ACTIVITY TO WHICH THIS NOTICE RELATES**

Without planning permission, there has been an unauthorised change of use from an Oil Storage Depot to a Mixed Use facility providing container storage, artist studio/classroom, and office accommodation.

- 4. WHAT YOU ARE REQUIRED TO DO**

You are required to regularise the breach of planning control by:


- Submitting a planning application for the development stated in paragraph 3 above; or
- Cease the use of the land for the provision of rented office accommodation, Storage Container Rental and studio/classroom facilities.

- 5. TIME FOR COMPLIANCE**

28 days after the date of this notice.

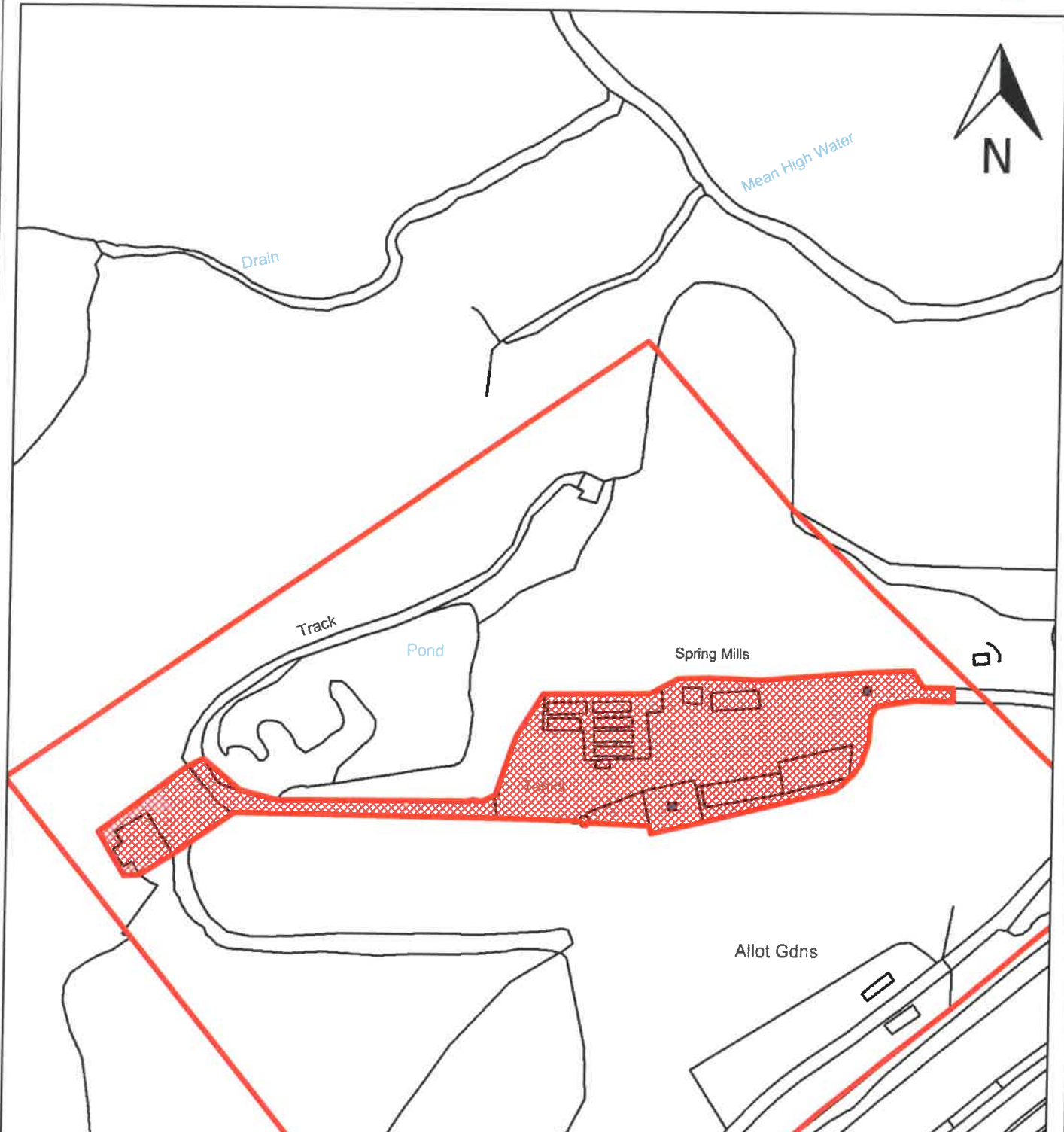
