Part 2

Acts and events leading to amendment.

A historic application for the amendment of a register in relation to a right of common under section 13 of the Commons Registration Act 1965, was made to the Commons Registration Authority on 6th December 2000.

The application proposes to amend original entry 267 of the register unit CL:015 Fairwood & Clyne Common, due to conveyance for the purchase of land of approximately 32.5 acres of land historically known as Werganows Farm.

The applicant claims that an apportionment is due on the rights attached to the acquired land as per the entries in the Register of Common Land.

This will result in 2 new entries into the register to replace Entry No. 267 as shown in Part 1 hereto; one setting out the rights as apportioned to the land acquired by the Applicant and one for the land remaining under the original registration.
