

### COMMONS REGISTRATION ACT 1965 – SECTION 13 Notice of Application for Amendment of Register In relation to Rights of Common

## Register Unit CL:16 Bishopston Valley Common Application No. 2693(s)

Application has been made to the City and County of Swansea by Mr Edward Solomon for the amendment of the Register of Common Land in relation to the registered right of common of which particulars are given in part 1 of the Annex hereto. #### Part 2

Acts and events leading to amendment.

A historic application for the amendment of a register in relation to a right of common under section 13 of the Commons Registration Act 1965, was made to the Commons Registration Authority on 24<sup>th</sup> September 2003.

The application proposes to amend the original entry 100 of the register unit CL:016 Bishopston Valley Common due to conveyance for the sale of approximately 8 acres, the land historically known as Werganrows Farm.

The applicant claims that an apportionment is due on the rights attached to the acquired land as per the entries in the Register of Common Land.

This will result in 2 new entries into the register to replace Entry No. 100 as shown in Part 1 hereto; one setting out the rights as apportioned to the land acquired by the Applicant and one for the land remaining under the original registration.
